








BROADLAND GROUP HAS ESTABLISHED ITS CORPORATE OFFICES IN SPAIN.

Although the operations might happen around the world, and with other companies of the Group, the decission point for most of the agreements and commercial partnerships sits in Europe.



HOW WE STARTED IN LATIN AMERICA?

In Latinamerica, Broadland started operation in the Glass Manufacturing Sector, developing well known brands in the Region, in the Architectural and Automotive Glass Industries.

Also developed an exclusive Cooperation with Top Wordwide suppliers like Fuyao in the Automotive Glass Industry and with top brands in the Glass Industry such guardian or Saint-Gobain Corporation.

Exclusive Distributor for Tata Motors in Venezuela in the and most appointed by Italian Brand Momo as Official Distribuitor for Venezuela and the Caribbean.

In the Automotive Industry Broadland Group has more than 10 years Experience as Distribuitor for Jeep, Chrysler, Kia, Fiat, Hyundai in Venezuela.



OUR EXPERIENCE IN LATIN AMERICA

Broadland has also wide experience in the Spare Parts industry being Distributor of Mopar, Valeo, etc for the Venezuelan market.

The Group has expanded not only in the manufacturing but in the Distribution and Retail sectors in order to guarantee the quality and delivery for our Customers though a Network of Warehouses, Distribution Centers and Shops across Venezuela, Colombia, Aruba and U.S.A.

Broadland holdings has a plastic manufacturing company, Deplayen, to supply the demand in disposable cupsand plastic solutions to the Venezuelan market.



OUR INFRASTRUCTURE IN VENEZUELA

Broadland group has 2 strategic warehouses. One is located in the free zone of Guaranao port where the group has also a container yard and its own custom broker agency for all the imports and exports in Venezuela. The other is located in Maracay where is also located one of our deep processing glass factory.

Moreover there are smaller storaging warehouses locations in 17 other locations in the country

This infrastructure is essential to guarantee the supply coming to the region, as well as being a hub for the distribution to and from the neighbouring countries.

OUR INFRASTRUCTURE IN VENEZUELA

The Group created a transportation company, "Ruedas del Centro" in the year 2009, in order to guarantee the supply to all our distribution centers.

The company has 50 vehicles that can meet the distribution needs of all our customers.

In 2010 we established a custom broker agency with an experienced team in customs clearance, in order to guarantee the legal requirements in all our import and exports.

In 2016 Broadland acquired the exclusive distribution of Chigo for Venezuela, diversifying into the home appliances.



OUR EXPERIENCE IN COLOMBIA

In Colombia Broadland holdings has 2 main warehouses, one located in Barranquilla port which receives all imports coming from westbound and other located in Bogota which receives through Buenaventura Port all eastbound shipments.

In order to get to our customers b2b and b2c, the Group acquired 15 shops in Colombia, that combined with the main warehouses, aim to cover the demand of the country.



After a very successful story in Venezuela in vehicle dealership, auto parts and accessories, and auto glass manufacturing for 20 years, representing top industry brands in Venezuela and Colombia.

The group started conquering the Islands markets. We wanted to:

OUR INFRASTRUCTURE IN CARIBBEAN ISLANDS

Broadland Holdings has branches in Aruba, Curação, and Bonaire.

The main warehouse in Oranjestad (Aruba) with 20.000 sq metres is currently the central point for the distribution in the Islands.

In terms of Retail, there is a shopping center with 24 offices and 12 stores in a strategic location in the Island. And another retail spot in the middle of the island.

In Curação, the Broadland also has 3 stores, and a warehouse for the island.


